STUDY SESSION

1. PLN 19-0101, PLEASANT HILL RECREATION & PARKS DISTRICT NEW UTILITY BUILDING AT 2 SANTA BARBARA ROAD (PLEASANT OAKS PARK)

The Architectural Review Commission will conduct a study session, and provide design review feedback, on a request by the Pleasant Hill Recreation & Parks District - PHRPD (property owner) to consider Architectural Review Permit PLN 19-0101 to amend an approved Architectural Review permit that granted site improvements completed on the 11-acre Pleasant Oaks Park site. The project site is currently developed as a *Park and Recreational Facility*. Specifically, the proposed Architectural Review Permit is requesting to establish a 2,196 square foot utility building, in the existing *park and recreation facility* use, primarily to provide storage for the local youth baseball league and the PHRPD. In addition, the building would displace 10 parking spaces and provide additional landscaping. The property is zoned *R-10 Single Family Residential – Medium Density*.
