1. <u>PLN 20-0243, SHELL GAS STATION EXTERIOR IMPROVEMENTS AND SIGNAGE,</u> 606 CONTRA COSTA BLVD.

Public hearing for a proposed Architectural Review Permit (PLN 20-0243) for a reface of an existing monument sign, including a new LED pricing display, and to install new fascia and logo signs on an existing canopy, including an LED light bar. The subject site is located at 606 Contra Costa Blvd. The property is zoned *Retail – Retail Business*. Assessor Parcel Number: 150-270-002.

<u>CEQA:</u> Class 1 and 11 Exemption – Modifying building colors on an existing building and canopy and new signage

2. <u>PLN 20-0296, DOWNTOWN PLEASANT HILL COLOR CHANGE, 15-140 CRESCENT DRIVE, 155-157 CRESCENT PLAZA, 60 GREGORY LANE</u>

Public hearing for a proposed Architectural Review Permit (PLN 20-0296) for exterior building color changes to the Downtown Pleasant Hill Shopping Center. The proposal includes updated colors for the entire Downtown Shopping Center and includes the use of grays, whites, blues, reds, and browns, all Benjamin Moore Paint selections. The subject site is the Downtown Pleasant Hill Shopping Center, located at 15-140 Crescent Drive, 155-157 Crescent Plaza and 60 Gregory Lane. The property is zoned *PUD DSP – Downtown Specific Plan*. Assessor Parcel Numbers: 150-300-001 through 007, 010 through 013.

3. <u>PLN 20-0279, TERRACES BUILDING MASTER SIGN PROGRAM AMENDMENT, 2300 CONTRA COSTA BOULEVARD</u>

Public hearing for a proposed Sign Permit (PLN 20-0279) to amend an existing Master Sign Program (MSP), at an existing multi-story office building. The MSP amendment is required to accommodate a new multi-story office sign for National Financial Partners (NFP). The proposed sign is approximately three feet in height and 11.7 feet wide; approximately 35.4 square feet. The site is located at 2300 Contra Costa Boulevard. The property is zoned *PUD DSP – Downtown Specific Plan*. Assessor's Parcel Number is 148-020-010.

<u>CEQA:</u> Class 11 (Accessory Structures) categorical exemption, since the project scope is limited to on–premise signage.
