STATE MANDATED SB1186

"Under federal and state law, compliance with disability access laws is a serious and significant responsibility that applies to all California building owners and tenants with buildings open to the public. You may obtain information about your legal obligations and how to comply with disability access laws at the following agencies:

ADJUSTMENT: The business license ordinance provides an annual adjustment in the license tax based on the Consumer Price Index.

DUE DATE: January 1 or date business opened.

DELINQUENT: February 1 or 30 days after opening.

PENALTIES: 20% per month or portion of a month delinquent, up to 100%.

An estimate of gross receipts and subcontractor payments may be used in determining the current license tax. Both are subject to audit periodically, and applicant consents and agress to permit examination of records to verify the estimated amounts reported on the original application. Within 30 days of the expiration of this license, applicant shall furnish a statement to support original estimates to determine any adjustments.
